#### **Local Law No. 15 of the year 2009**

**A local law** to amend the Code of the Town of Colonie, Chapter 171 thereof, entitled Taxation, by deleting and repealing Article V, Homestead and Nonhomestead Base Proportions.

**Be it enacted by the Town Board of the Town of Colonie of as follows:**

Section 1.

The Code of the Town of Colonie is hereby amended by deleting and repealing Article V, Homestead and Nonhomestead Base Proportions, of Chapter 171, Taxation.

Section 2.

This local law shall become effective immediately upon its proper filing with the Secretary of State.

**5. (City local law concerning Charter revision proposed by petition.)**
