**Town of Colonie  
Local Law No 12 of the year 2017**

**A local law** amending Chapter 171 of the Code of the Town of Colonie, entitled “Taxation” by extending the duration of the Cold War Veterans Exemption from ten years to as long as the qualified owner of qualified residential real property remains a qualified owner.

**Be it enacted by the Town Board of the Town of Colonie of as follows:**

**SECTION 1. DURATION OF EXEMPTION**

Section 171-10.3, entitled “Duration of exemption” is hereby amended to read as follows:

The exemption provided by this article shall apply to a qualified owner of qualified residential real property for as long as they remain a qualified owner, without regard to the ten year limitation set forth in section 458-b of the Real Property Tax Law.

**SECTION 2. SEVERABILITY**

If any clause, sentence or provision of this local law or the application thereof to any person or circumstance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity thereof shall not affect, impair or invalidate the remainder of the provisions of this local law or the application thereof to other persons and circumstances.

**SECTION 3. SEQR DETERMINATION.**

The Town hereby determines that the adoption of this amendment, which provides for the extension of the duration of the Cold War Veterans Exemption, is an unlisted action that will not have a significant effect on the environment and, therefore, no other determination or procedure under the State Environmental Quality Review Act (“SEQRA”) is required.

**SECTION 4. EFFECTIVE DATE**

This local law shall take effect immediately upon its filing in the Office of the Secretary of State and shall apply to assessment rolls prepared on or after March 1, 2018.

**5. (City local law concerning Charter revision proposed by petition.)**
