**Local Law No. 9 of the year 2009**

A **local law** amending the rezoning of land located at 1035 Loudon Road (Canterbury Crossing).

**Be it enacted by the Town Board of the Town of Colonie of as follows:**

SECTION 1.

The following described area consisting of 3.86 ± acres of a portion of land located at 1035 Loudon Road:

ALL THAT TRACT OR PARCEL OF LAND situate in the Town of Colonie, County of Albany, and State of New York more particularly described on the Albany County Tax Map as Section 9.4, Block 2, Lot 1 (1035 Loudon Road) as depicted upon the map attached hereto.

SECTION 2. CONDITIONS

The subject 3.86 ± acre parcel described in Section 1 above is rezoned to a Planned Development District upon the condition that it be developed as 26,721 sq. ft. facility including a fire house, a fire hall, administrative offices, a Town Emergency Medical Services station, and a garage/pavilion structure.

SECTION 3. EFFECTIVE DATE

This local law shall take effect upon its proper filing in the Office of the Secretary of State.
