1 MS. GANSLE: This public hearing is being  
2 continued by Resolution of the Town Board number 297  
3 for 2019 dated June 27, 2019 to continue to hear all  
4 persons in connection with a proposed Local Law  
5 amending the Code of the Town of Colonie Chapter 181  
6 entitled Vehicle and Traffic Codification by amending  
7 Schedule V, stop intersections.

8 The Town Board will now here all persons interested  
9 in this matter.

10 MR. MAGGUILLI: As the Town Board knows, we  
11 received a request by a resident, Mr. Nottke, to have a  
12 traffic control device placed at the intersection of  
13 Ace Place and Sherwood Drive in an easterly direction  
14 of travel.

15 The matter had gone before our Traffic Safety  
16 Committee. The Traffic Safety Committee recommended a  
17 stop sign at the center section.

18 We have received a communication from Mr. Nottke.  
19 My assistant, Allegra Edelman, has left me an email  
20 regarding communication that she had and Mr. Nottke  
21 would request that the Town Board consider placing a  
22 stop sign rather than a yield sign at that intersection.  
23 That goes along with the endorsement of our Traffic  
24 Safety Committee that also recommended a stop sign at  
25 this intersection.

1 SUPERVISOR MAHAN: Any questions or comments?

2 (There was no response.)

3 We'll close the public hearing.

4 MS. GANSLE: We have a Resolution adopting a  
5 proposed Local Law amending Chapter 181 of the Code of  
6 the Town of Colonie - "Vehicle & Traffic Codification"  
7 by amending the following schedule thereof: Schedule V  
8 - "Stop Intersections".
