A local law amending Chapter 181 of the Code of the Town of Colonie - "Vehicle & Traffic Codification" by amending Schedule X – "No Parking Certain Hours".

Be it enacted by the Town Board of the Town of Colonie of as follows:

SECTION 1.

Chapter 181 of the Code of the Town of Colonie, Schedule IX entitled "No Parking Anytime" is hereby amended by adding the following:

Computer Drive West	East and South (inside loop)	From its intersection with Automation Lane to its intersection with Cerone Commercial Drive (1,650 feet plus or minus)

SECTION 2.

Chapter 181 of the Code of the Town of Colonie, Schedule X entitled "No Parking Certain Hours" is hereby amended by adding the following:

<u>Name of Street</u>	<u>Side</u>	<u>Hours</u>	<u>Location</u>
Computer Drive West	West and North (outside loop)	7:00 p.m. to 6:00 a.m.	From its intersection with Automation Lane to its intersection with Cerone Commercial Drive (1,650 feet plus or minus)

SECTION 3.

Chapter 181 of the Code of the Town of Colonie, Schedule X entitled "No Parking Certain Hours" is hereby amended by deleting the following:

<u>Name of Street</u>	<u>Side</u>	<u>Hours</u>	<u>Location</u>
Computer Drive West	Both	7:00 p.m. to 6:00 a.m.	From its intersection with Automation Lane to its intersection with Cerone Commercial Drive (1,650 feet plus or minus)
