Local Law No. 8 of the year 2016**

A local law amending Chapter 181 of the Code of the Town of Colonie – “Vehicle & Traffic Codification” by amending Schedule I entitled “Traffic Control Signals”.

Be it enacted by the Town Board of the Town of Colonie as follows:

SECTION 1.

Chapter 181 of the Code of the Town of Colonie, Schedule I entitled “Traffic Control Signals” is hereby amended by deleting the following language:

Intersection or Location

Route 155 and Sand Creek Road

SECTION 2.

Chapter 181 of the Code of the Town of Colonie, Schedule I entitled “Traffic Control Signals” is hereby amended by adding the following traffic control signals:

Intersection or Location

Haswell Road and Swatling Road

Sand Creek Road and Osborne Road East

Sand Creek Road and Osborne Road West

Albany Shaker Road and Maria Drive

Route 155 and Vly Road

Albany Shaker Road and Emerick Lane
