**Town of Colonie
Local Law No 13 of the year 2017**

A local law amending Chapter 181 of the Code of the Town of Colonie, entitled “Vehicles and Traffic” by adding a schedule of crosswalks.

Be it enacted by the Town Board of the Town of Colonie of as follows:

SECTION 1.

Chapter 181 is hereby amended by adding section 181-17A, entitled “Crosswalks,” as follows: The crossing areas described in Schedule XV (§181-43) are hereby designated as crosswalks, and appropriate markings and/or signage for such crosswalks shall be made and/or erected.

[Note: Vehicle and Traffic Law § 1151 regulates drivers of vehicles and pedestrians at crosswalks.]

SECTION 2.

Chapter 181 is hereby amended by establishing Schedule XV (section 181-43), as follows: In accordance with the provisions of § 181-17A, the following described crossing areas are designated as crosswalks, and markings and/or signage shall be made and/or erected as indicated:
Location of Crosswalk
Intersection of Aviation Road and Mulberry Drive (Signage shall include sign R1-6¹ from the Manual on Uniform Traffic Control Devices for Streets and Highways [2009].)

SECTION 3. SEVERABILITY

If any clause, sentence or provision of this local law or the application thereof to any person or circumstance shall be adjudged by a court of competent jurisdiction to be invalid, the invalidity thereof shall not affect, impair or invalidate the remainder of the provisions of this local law or the application thereof to other persons and circumstances.

SECTION 4. SEQOR DETERMINATION.

The Town hereby determines that the adoption of this amendment, which establishes a schedule of crosswalks, is an unlisted action that will not have a significant effect on the

environment and, therefore, no other determination or procedure under the State Environmental Quality Review Act (“SEQRA”) is required.

SECTION 4. EFFECTIVE DATE

This local law shall take effect immediately upon its filing in the Office of the Secretary of State.

5. (City local law concerning Charter revision proposed by petition.)

I hereby certify that the local law annexed hereto, designated as local law No. _____ of 2017 of the City of _____ having been submitted to referendum pursuant to the provisions of section (36)(37) of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of such city voting thereon at the (special)(general) election held on _____ 2017, became operative.

6. (County local law concerning adoption of Charter.)

I hereby certify that the local law annexed hereto, designated as local law No. _____ of 2017 of the County of _____ State of New York, having been submitted to the electors at the General Election of November _____ 2017, pursuant to subdivisions 5 and 7 of section 33 of the Municipal Home Rule Law, and having received the affirmative vote of a majority of the qualified electors of the cities of said county as a unit and of a majority of the qualified electors of the towns of said county considered as a unit voting at said general election, became operative.
