

NOTES:

- 1. At the Latham Water District's discretion, a Water Service Application may be invalidated one year after issuance and Connection Fees paid will be forfeited.
- 2. Residential properties are defined as properties with the following Property Class Codes: 210, 211, 215, 220, 221, 240, 250, 260, 261, 270, 271, 280,281,310 and 311 Commercial Properties are properties not in a residential Property Class Code.
- 3. For water services to be installed in New York State Department of Transportation, County of Albany and significant Town of Colonie rights of way.
- 4. If the request to turn the water service back on is made more than 48 hours after the request to turn it off, a second Water Off/On charge will be assessed. This fee will be added to the next water bill.
- 5. This fee will be applied to the next water bill.
- 6. For any changes to the existing water service including water meter, backflow preventer, etc. that does not require a new water service. Additional Fees as outlined above may apply.
- 7. All rates and fees listed in this schedule will be added to the next water bill. Unpaid account balances shall be subject to a 10% late penalty. Unpaid accounts will be reassessed on the General Land Tax Bill as of November 30.
- 8. At the discretion of the Water District Superintendent or as mandated by code, rule or regulations these alternate meter types may be installed.
