

NOTICE OF SPECIAL ELECTION OF
STANFORD HEIGHTS FIRE DISTRICT
September 14, 2021

NOTICE is hereby given pursuant to the Town Law of the State of New York, that a Special Election of the Stanford Heights Fire District will take place on September 14, 2021 between the hours of 5:30 p.m. and 9:00 p.m. at the Stanford Heights Fire House, 2240 Central Avenue, Schenectady (County of Albany) New York for the purpose of voting upon the following proposition.

All residents of the Stanford Heights Fire District, who were duly registered to vote with the Albany or Schenectady County Board of Elections on or before August 23, 2021 shall be entitled to vote at this election.

PROPOSITION

Shall the Resolution of Stanford Heights Fire District in the Counties of Albany and Schenectady, State of New York, entitled " **BOND RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE STANFORD HEIGHTS FIRE DISTRICT, TOWNS OF COLONIE AND NISKAYUNA, ALBANY AND SCHENECTADY COUNTIES, NEW YORK, ADOPTED AUGUST 3, 2021, AUTHORIZING THE DEMOLITION OF THE EXISTING FIRE STATION LOCATED AT 2240 CENTRAL AVENUE, TOWN OF COLONIE, NEW YORK AND THE ACQUISITION, CONSTRUCTION AND EQUIPPING OF AN APPROXIMATELY 24,504 SQUARE FOOT FIRE STATION (HAVING AN APPROXIMATELY 17,293 SQUARE FOOT FOOTPRINT) AT THE SAME LOCATION, INCLUDING GRADING AND SITE IMPROVEMENTS AND ORIGINAL FURNISHINGS, EQUIPMENT, MACHINERY AND APPARATUS REQUIRED FOR THE PURPOSES FOR WHICH SUCH FIRE STATION IS TO BE USED, STATING THE ESTIMATED MAXIMUM COST OF SAID DEMOLITION, ACQUISITION, CONSTRUCTION AND EQUIPPING TOGETHER WITH CERTAIN COSTS PRELIMINARY AND INCIDENTAL THERETO IS \$12,500,000.00, APPROPRIATING SAID AMOUNT THEREFOR AND AUTHORIZING THE EXPENDITURE OF \$2,300,000.00 FROM THE DISTRICT'S CAPITAL FUND AND THE ISSUANCE OF UP TO \$10,200,000.00 SERIAL BONDS OF THE DISTRICT TO FINANCE SAID APPROPRIATION**" be approved?
